- 1. Statement Date:** The dates for which you're getting paid
- 2. Earnings:** Regular pay, overtime pay, holiday pay, etc.
- 3. Hours:** How many hours you worked during the pay period
- 4. Rate:** Your hourly rate of pay
- 5. Current Amount:** How much this total payment is for (hours x rate)
- 6. Withholdings:** Federal and state required taxes
- 7. Voluntary Deductions:** 401(k), HSA, etc.
- 8. Current Amount:** How much is being withheld for this check
- 9. Year to Date:** How much has been withheld since the beginning of the year, or start of your employment
- 10. Net Pay:** Current Amount minus Current Withholding (how much money will show up in your bank account)
- 11. Year to Date Amount:** How much you've made this year, before withholdings
- 12. Year to Date Net Pay:** How much money has been deposited, after withholdings
