- The styles and WYSIWYG editor were updated for Your Portfolio > Messages.




2. TRANSCRIPT NOTIFICATIONS

My Colleges > Transcripts


The professional will receive an email indicating that new or existing transcript requests are pending. The email will be generated daily until the transcript requests are acted upon.



Sample Email


3. LICENSED ACTIVITIES

Assignment & Curriculum Builder Find Activities



4. WORK-BASED LEARNING EXPERIENCES ACTIVITY


The Job Shadowing activity was reclassified from an exposure activity to an engagement activity. Existing Job Shadowing exposure experiences were updated to engagement experiences.

The Annual Reflection activity was updated to use the new form and button styles. The summary mode was also updated.




Annual Reflection Activity Panel




Annual Reflection Summary

The Saved Career Clusters and Career Pathways activity was updated to use the new form and button styles. The summary mode was also updated.




Saved Career Clusters and Career Pathways Activity Panel




