#### **RELEASE NOTES SUMMARY**

These release notes detail the product improvements and new features included in the October 4<sup>th</sup>, 2023, release.

#### **Resolved Issues**

- 1. When viewing the My Goals & Actions Plans and Work-Based Learning Experiences activity landing pages, the student's name is now displayed at the top of the page.
- 2. When viewing Your Portfolio > Index, the Index menu is now highlighted.
- 3. The correct validation message now displays when renaming a curriculum in Assignment & Curriculum Builder.
- 4. The width of the student survey text boxes was increased to provide full access to the student responses.
- 5. The 'Print This', 'Email This', and 'PDF This' windows are no longer truncated. Students can once again print, email, or PDF Interest Profiler activity information.
- 6. When creating or editing a survey, a scroll bar was added to the 'Edit survey setting's modal to prevent it from being truncated when all fields are expanded.



# 5. ALUMNI OUTCOMES: TOP 25 COLLEGES FIRST ATTENDED

The National Student Clearinghouse (NSC) released a new report that contains data on the top 25 postsecondary institutions that your high school graduates first attended within the two years of exiting high school.

The report is a CSV file that contains at least one row for each student you submit. If the student record matches postsecondary records in the Clearinghouse's database, the record found indicator will equal "Y," and those records will be returned to you in this report. Only postsecondary records on which the student has not placed a FERPA block are included in this report.

All NSC reports are available to schools with add-on licenses for Alumni Outcomes.
