## **RELEASE NOTES SUMMARY**

These release notes detail the product improvements and new features included in the November 1, 2023, release.

### **Resolved Issues**

1. When creating a temporary password for a student in the Professional Center, hitting the Enter key did not save the temporary password.
2. The numbers showing answered or skipped survey responses were not displaying properly to professional account holders.
3. When using “Print This, Email This or PDF This” options in Your Profile→ The Basics in the Student Center, the PDF file included the words “loading”.
4. When using “Print This, Email This or PDF This” options in Your Profile→ The Basics in the Student Center, the PDF file does not include the Parents/Guardians section.
5. In the Professional Center, the school icon (located at the upper right) was not displaying properly.
6. When selecting the “PDF This” button from the Transferable Skills Checklist results, the Save PDF and Cancel buttons were overlapping.
7. When viewing the Interest Profiler, disabled tabs were displaying as clickable.
8. Students can extend the “Write any additional thoughts about your interests” input text box (on the Interest Profiler results page) beyond the results page.
9. When selecting Career Planning > College Planning > Your Profile in the Student Center, the sub-navigation menu is not highlighted when selecting a page.
10. When adding or editing an Opportunity in the Work-Based Learning module, the text boxes can be expanded past the end of the page.
11. When a parent attempts to view their student’s resume in the Resume Builder activity, the link doesn’t display the resume.
12. The content in the Manage Professional Accounts section did not include access to work-based learning for Professional Accounts.
13. The display of the page numbers and Search/Go buttons on the results table for the School Finder was incorrect.
14. The column headers in the results table for the Career Finder were displaying incorrectly.
15. The Brag Sheet in My Colleges & Applications did not display the appropriate Portfolio Activities.
16. In the Professional’s view of a student’s portfolio, AP exams and GED were combined into one display when they should have been separated.

17. When resizing the Apply to College page in College Planning, the page numbers did not display correctly.
18. Adults using the Work History tool were not able to access the Aptitudes section of the tool.
19. Students using "Email This" could expand the Your Message input field beyond the panel.
20. An error was displayed when a Professional viewed a student's saved resume.
21. The "Start your plan now" button in the Career Plan Builder was incorrectly displaying as inactive.

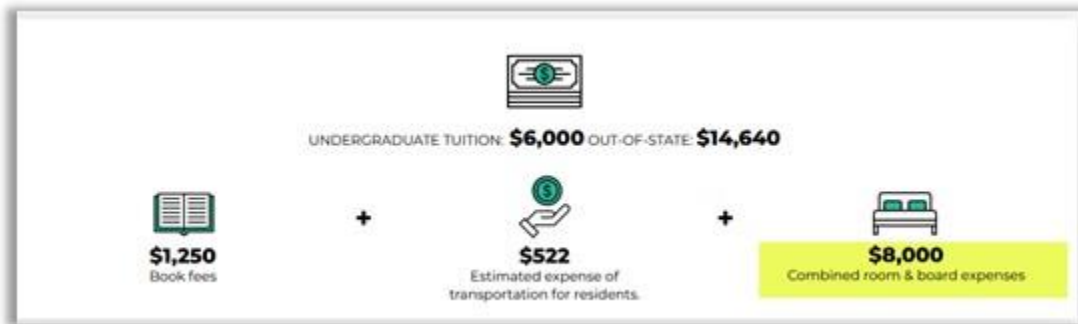

19	Students using "Email This" could expand the Your Message input field beyond the panel. (PPS-5803)	The Your Message input field can no longer be expanded beyond the panel.
20	An error was displaying when a Professional was viewing a student's saved resume. (PPS-5680)	The resume now displays correctly.
21	The "Start your plan now" button in the Career Plan Builder was incorrectly displaying as inactive. (PPS-5792)	The button is now active.
