RELEASE NOTES SUMMARY

These release notes detail the product improvements and new features included in the March 28th, 2024, release.

Resolved Issues

- 1. The IB test score activity could be saved without entering a course.
- 2. Parent accounts were able to access unlicensed assessments.
- 3. The activity, Self-Knowledge, when assigned in a curriculum was incorrectly displaying text when a student cancelled their entry (if any).
- 4. The College Savings Calculator was not updating Additional Funds when Total Future Cost was updated.
- 5. The Federal Student Aid Estimator activity was missing as an option in the Milestone Tracking report.
- 6. The report, Completed EFC Calculator, is incorrect and should be Federal Student Aid Estimator.
- 7. The default sort order in a group was random instead of ordered.
- 8. When printing Interest Profiler results, the results bars overlapped the RIASEC images.
- 9. The Compare Schools feature (onscreen and print) was not displaying properly.
- 10. An error message was missing when users entered an email as their username and also selected "use this site's email account as your primary email".
- 11. The checkbox on the Privacy and Terms of Use modal was not easily visible to students.
- 12. The Resume Builder activity was not showing as complete when it was completed.



1	The IB test score activity could be saved with a score but without entering a course. (PPS-4669)	A course must now be selected in addition to a score when saving.
2	Parent accounts were able to access unlicensed assessments. (PPS-5346)	The unlicensed assessments are no longer accessible.
3	The activity, Self-Knowledge, when assigned in a curriculum was incorrectly displaying text when a student cancelled their entry (if any). (PPS-5563)	The problem was corrected.
4	The College Savings Calculator was not updating Additional Funds when Total Future Cost was updated. (PPS-5582)	The Additional Funds now updates correctly when Total Future Cost is changed.
5	The Federal Student Aid Estimator activity was missing as an option in the Milestone Tracking report. (PPS-6361).	The activity has been added as an option when filtering by individual milestones.
6	The report, Completed EFC Calculator is incorrect and should be Federal Student Aid Estimator. (PPS-6361)	The report has been renamed and text updated.
7	The default sort order in a group was random instead of ordered. (PPS-6480)	The default sort order has been updated to sort by graduation year then alphabetical.
8.	When printing Interest Profiler results, the results bars overlapped the RIASEC images. (PPS-6487)	The print output has been updated.
9.	The Compare Schools feature (onscreen and print) was not displaying properly. (PPS-6498)	It now displays correctly.

	Problem	Improvement
10.	An error message was missing when users entered an email as their username and also selected "use this site's email account as your primary email". (PPS-6528)	The error message was added.
11.	The checkbox on the Privacy and Terms of Use modal was not easily visible to students. (PPS-6541)	The checkbox was darkened.
12.	The Resume Builder activity was not showing as complete in the My Progress sidebar when it was completed. (PPS-6571)	The activity now shows complete as expected.

3. COMPASS PROFILE UPDATED

The newest release of Compass includes features to help students more easily update their profiles and search for opportunities. These features include:

- The **new Compass home page** offers improved navigation that corresponds to the mobile app. Students can now view their profile, results, opportunities, and activity from the home page and the top navigation.
- The **new notification features** on the home page include a profile progress graphic and alerts for new matched opportunities and activities awaiting action.
- The new employer page enables students to learn more about an employer and all
 of its related opportunities from one location, including work-based learning and
 Career Profiles. This provides an additional way to browse opportunities, especially
 if students are interested in working for particular employers.
- Email notifications of when an employer accepts or rejects a work-based learning opportunity will now be sent to school professionals, so they know when an offer is made.
